PUBLIC NOTICE – PUBLIC EXHIBITION OF DRAFT ALTERATIONS TO THE *FISHERIES (GENERAL AND FEES) REGULATIONS 2016* REGARDING THE ABALONE AND SCALLOP FISHERIES AND MISCELLANEOUS

I, Dr Ian Dutton, General Manager (Marine Resources) hereby give notice that:

- The *Fisheries (General and Fees) Regulations 2016* regarding the abalone and scallop fisheries and miscellaneous are proposed to be altered.
- The objects of the proposed alterations are:
 - increases to size limits in the commercial blacklip abalone fishery;
 - that the period for which a management plan may be extended be increased from 12 to 24 months;
 - that a person transporting fish on behalf of the holder of a fish processing licence or handling licence be required to keep records; and
 - regarding Schedule 1, Part 1 Fishing licences, 9 Fishing licence scallop, a) Renewal, (ii) fixed component, the proposed amendment is to alter the fixed component from a flat 8 fee units per scallop quota unit to a two tiered system based on scallop total allowable catch.
- A person may submit written representations in relation to any proposed alteration.
- Copies of the proposed alterations, the *Fisheries (General and Fees) Amendment Regulations 2022*, may be viewed, or obtained at no cost, from the Fisheries Compliance and Licensing Branch of the Department of Natural Resources and Environment Tasmania, located on the first floor of the Lands Building, 134 Macquarie Street, Hobart.


