

### *Living Marine Resources Management Act 1995* *Fisheries (Shellfish) Rules 2017*

#### PUBLIC NOTICE OF THE TOTAL ALLOWABLE COMMERCIAL CATCH FOR THE SHELLFISH FISHERY

I, Dr Ian Dutton, General Manager (Marine Resources) in the Department of Natural Resources and Environment Tasmania, acting pursuant to a delegation from the Minister for Primary Industries and Water made on 13 July 2022 and acting pursuant to section 20(1) of the *Living Marine Resources Management Act 1995* (the Act), hereby determine under rule 7 of the *Fisheries (Shellfish) Rules 2017* (the Rules):

- A. The total allowable commercial catch of native oysters (molluscan bivalves of the species *Ostrea angasi*) that may be taken in the period from 1 September 2022 to 31 August 2023 is 25,330 dozen, and this is to be taken from the fishery part defined in the Rules as Georges Bay; and
- B. The total allowable commercial catch of *Venerupis* clams (molluscan bivalves of the genus *Venerupis*) that may be taken in the period from 1 September 2022 to 31 August 2023 is 840 kilograms, and this is to be taken from the fishery part defined in the Rules as Georges Bay North Clam Zone; and
- C. The total allowable commercial catch of *Katelysia* cockles (molluscan bivalves of the genus *Katelysia*) that may be taken in the period from 1 September 2022 to 31 August 2023 is 0 kilograms, and this is to be taken from the fishery part defined in the Rules as Ansons Bay Cockle Zone.

Any expression used in this notice having a particular meaning under the Act or the Rules has the same meaning in this notice.

- a) the dates of the open seasons for the **commercial** rock lobster fishery for **male** rock lobster are as follows:
  - open season from 00:01 15 November 2022 for all State waters excluding the **East Coast stock rebuilding zone**; and
  - open season from 00:01 1 March 2023 for the **East Coast stock rebuilding zone**.
- b) the dates of the closed seasons for the **commercial** rock lobster fishery for **male** rock lobster are as follows:
  - closed season from 00:01 1 September 2023 for the "September closed region"; and
  - closed season from 00:01 1 October 2023 for all State waters.
- c) the dates of the open and closed seasons for the **commercial** rock lobster fishery for **female** rock lobster are as follows:
  - open season from 00:01 15 November 2022 for all State waters excluding the **East Coast stock rebuilding zone**;
  - open season from 00:01 1 March 2023 for the **East Coast stock rebuilding zone**; and
  - closed season from 00:01 1 May 2023 for all State waters.

where:

**East Coast stock rebuilding zone** means-

- a) all State waters off the east coast of Tasmania bound in the north by the line of latitude 40° 59' 35" South commencing from the highwater mark Eddystone Point and running due east to the outer limit of State waters, and bound in the south by the line of latitude 43° 30' 58" South commencing from the high water mark Tasman Head and running due east to the outer limit of State waters.
- b) Including waters of the **D'Entrecasteaux Channel**.

and where:

**D'Entrecasteaux Channel** is defined in the *Fisheries (Rock Lobster) Rules 2011*.

and where:

“**September closed region**” means State waters adjacent to the east, south and west coasts of Tasmania enclosed by an imaginary line starting at the high water mark on the east coast of the mainland of Tasmania at longitude 41° 16’ 30” East (St Helens Point), then running due east to the limit of State waters, then running in a clockwise direction at the limit of State waters until that imaginary line meets the line of latitude 41° 29’ 0” South off the west coast of Tasmania (3.7NM south of Sandy Cape), then running due east to the high water mark of the mainland of Tasmania and then running in an anticlockwise direction along the high water mark of Tasmania to the starting point of that imaginary line.

  - open season from 00:01 5 November 2022 for all State waters excluding the **East Coast stock rebuilding zone**;
  - open season from 00:01 3 December 2022 for the **East Coast stock rebuilding zone**; and
  - closed season from 00:01 1 May 2023 for all State waters.

where:

**East Coast stock rebuilding zone** means-

- a) all State waters off the east coast of Tasmanian bound in the north by the line of latitude 40° 59’ 35” South commencing from the high water mark Eddystone Point and running due east to the outer limit of State waters, and bound in the south by the line of latitude 43° 30’ 58” South commencing from the high water mark Tasman Head and running due east to the outer limit of State waters.
- b) Including waters of the **D’Entrecasteaux Channel**.

and where:

**D’Entrecasteaux Channel** and **Eastern Region** are defined in the *Fisheries (Rock Lobster) Rules 2011*.


