To: Tasmanian Liquor and Gaming Commission

I give you the following Direction under section 127 of the *Gaming Control Act 1993*.

Title

This Direction may be cited as the *Tasmanian Liquor and Gaming Commission Ministerial Direction (No. 2) 2022*.

Commencement

This Direction takes effect on 17 December 2022.

Direction

The Tasmanian Liquor and Gaming Commission is to:

1. investigate the introduction of gaming on simulated racing events at and from approved locations and approved outlets under the authority of Tasmanian gaming licences, including the impact of:
 - a. gambling on simulated racing events on total gambling losses and the level of gambling harm in the community in Tasmania; and
 - b. gambling on simulated racing events on participation in, and engagement with, other forms of gambling; and
 - c. the introduction of simulated racing events on employment in the gambling industry in Tasmania; and
2. provide me a report on the outcome of the investigations.

The report should include:

- a) recommendations on policy considerations, harm minimisation measures and regulatory considerations in relation to the conduct of simulated racing events and their implementation; and
- b) the steps that the Commission proposes to take to implement those recommendations as soon as reasonably practicable.

The report should be provided to me within six months of this Direction.



