GENERAL PURPORT OR EFFECT OF THE ABovementIONED STATUTORY RULES

(1) *Explosives Regulations 2022*

These regulations, made under the *Explosives Act 2012* –

- (a) prescribe various matters, including fees, infringement notice offences and penalties, in relation to –
 - (i) the use of explosives and fireworks; and
 - (ii) the performance of blasting and shot-firing; and
- (b) are made consequent on the repeal of the *Explosives Regulations 2012* under section 11 of the *Subordinate Legislation Act 1992*.

(2) *Residential Tenancy (Smoke Alarms) Regulations 2022*

These regulations –

- (a) prescribe matters in relation to smoke alarms in premises to which a residential tenancy agreement relates; and
- (b) are made consequentially on the repeal of the *Residential Tenancy (Smoke Alarms) Regulations 2012* under section 11 of the *Subordinate Legislation Act 1992*.

(3) *Mines Work Health and Safety (Supplementary Requirements) Regulations 2022*

These regulations –

- (a) prescribe, for the purposes of the *Mines Work Health and Safety (Supplementary Requirements) Act 2012*, certain measures specifically required to be taken in respect of mines, including the preparation of certain plans and systems; and

- (b) prescribe, for the purposes of the *Work Health and Safety Act 2012* –
 - (i) certain events as dangerous incidents under that Act; and
 - (ii) certain decisions as reviewable decisions under that Act; and
 - (iii) certain offences, under the *Mines Work Health and Safety (Supplementary Requirements) Act 2012*, as infringement offences and the penalties payable in respect of those offences; and
 - (c) are made consequent on the repeal of the *Mines Work Health and Safety (Supplementary Requirements) Regulations 2012* under section 11 of the *Subordinate Legislation Act 1992*.
- (4) *Animal Welfare (Land Transport of Livestock) Amendment Regulations 2022*
 These regulations amend the *Animal Welfare (Land Transport of Livestock) Regulations 2013* by –
- (a) clarifying the ventilation requirements for certain vehicles in specified circumstances; and
 - (b) providing an exemption to specified provisions of the *Animal Welfare Act 1993*, and the *Animal Welfare (Land Transport of Livestock) Regulations 2013*, in certain circumstances.
- (5) *Cat Management Regulations 2022*
 These regulations prescribe, for the purposes of the *Cat Management Act 2009* –
- (a) procedures for the approval, or the suspension or cancellation of approval, of cat management facilities in certain circumstances and the transfer of such approvals; and
 - (b) processes relating to the microchipping of cats; and
 - (c) other miscellaneous matters, including offences for which an infringement notice may be served.
- (6) *Biosecurity (Salmonid Biosecurity Zones) Regulations 2022*
 These regulations –
- (a) establish various salmonid biosecurity zones; and
 - (b) prescribe biosecurity measures in respect of those zones; and
 - (c) provide for the exemption of certain dealings, communications and other acts relating to the Salmonid Biosecurity Program from the application of Part IV of the *Competition and Consumer Act 2010* of the Commonwealth.
- (7) *Fisheries (General and Fees) Amendment Regulations 2022*
 These regulations amend the *Fisheries (General and Fees) Regulations 2016* by –
- (a) specifying a staged increase in the minimum size of certain abalone in certain specified areas; and
 - (b) increasing the maximum time period for which a management plan can be extended.
- (8) *Land Use Planning and Approvals Amendment Regulations 2022*
 These regulations amend the *Land Use Planning and Approvals Regulations 2014* by specifying that the implementation, or operation, of a container refund scheme is a circumstance where an interim SPPs amendment may be made by the Minister.
- (9) Proclamation under section 2 of the *Family Violence Reforms Act 2022*
 This proclamation fixes 22 December 2022 as the day on which sections 3, 4(b), 5, 8 and 11, and Parts 3, 5, 7, 8, 10 and 11, of that Act commence.
- (10) *Climate Change (Greenhouse Gas Emissions) Regulations 2022*
 These regulations prescribe, for the purposes of the *Climate Change (State Action) Act 2008* –
- (a) the method for measuring greenhouse gas emissions; and
 - (b) the annual publication requirements for Tasmania's greenhouse gas emissions.
- (11) *Threatened Species Protection Order 2022*
 This order amends the *Threatened Species Protection Act 1995* by –
- (a) adding certain species to, and omitting certain species from, the Schedules of endangered, vulnerable and rare flora and fauna; and
 - (a) updating certain taxonomic, authority and common name references in the Schedules.



