## Living Marine Resources

### *LIVING MARINE RESOURCES MANAGEMENT ACT 1995*

#### *Fisheries (Biosecurity) Order 2022*

Pursuant to the powers under section 270 of the *Living Marine Resources Management Act 1995* ("the Act") that were delegated to the General Manager (Marine Resources) on 13 July 2022 by the Minister for Primary Industries and Water pursuant to section 20(1) of the Act, I make the following order:

**1. Short title**

This order may be cited as the Fisheries (Biosecurity) Order 2022 No. 2

**2. Specification**

This order is made -

- (a) in respect of the harmful pest the soft-shell clam *Mya japonica*; and
- (b) to place restrictions on the take and/or possession and/or release of this harmful pest to control and prevent the spread and introduction or re-introduction of *Mya japonica* into areas of State waters.

**3. Directions issued**

- (1) That, unless otherwise authorised, a person must not take *Mya japonica* from State waters.
- (2) That, unless otherwise authorised, a person must not release *Mya japonica* in State waters.
- (3) That, unless otherwise authorised, a person must not possess *Mya japonica*.

**4. Interpretation**

In this order -

"authorised" means any person who is a fisheries officer or an employee of the Department of Natural Resources and Environment Tasmania, or the Tasmanian Museum and Art Gallery, undertaking research or biosecurity activities on the soft-shell clam *Mya japonica*.




