GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Road Amendment Rules 2022*

These rules amend the *Road Rules 2019* by inserting provisions to implement certain changes to the Australian Road Rules model law.

(2) *Traffic (Compliance and Enforcement) Amendment (Road Rules) Regulations 2022*

These regulations amend the *Traffic (Compliance and Enforcement) Regulations 2017* by prescribing a number of Road Rules offences consequent on the making of the *Road Amendment Rules 2022*.

(3) *Poisons Amendment (Miscellaneous) Regulations 2022*

These regulations make miscellaneous amendments to the *Poisons Regulations 2018*, including in relation to –

- (a) labelling requirements; and
- (b) the narcotic substances register; and
- (c) the administration of sodium fluoride varnish by dental assistants; and
- (d) various other matters.

(4) *Therapeutic Goods Regulations 2022*

These regulations –

- (a) require wholesalers of therapeutic goods to comply with the “Code of Good Wholesaling Practice for Medicines in Schedules 2, 3, 4 and 8”; and
- (b) contain labelling requirements for certain therapeutic substances; and
- (c) are made consequentially on the repeal of the *Therapeutic Goods Regulations 2012* under section 11 of the *Subordinate Legislation Act 1992*.

(5) *Vehicle and Traffic (Offence Detection Devices) Amendment Regulations 2022*

These regulations amend the *Vehicle and Traffic (Offence Detection Devices) Regulations 2012* by providing for the Transport Commission to approve the form that certain evidentiary certificates may take.

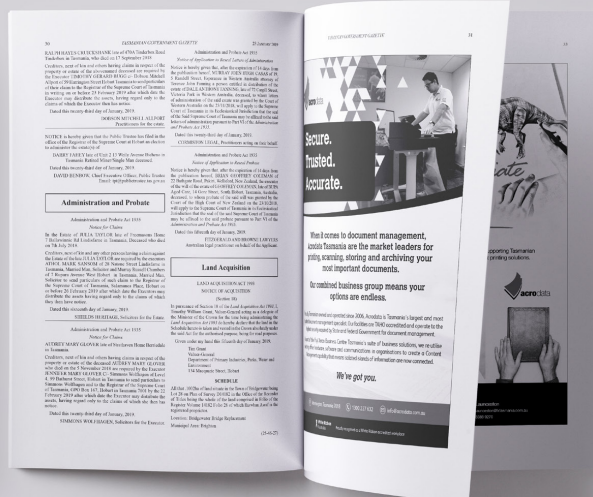
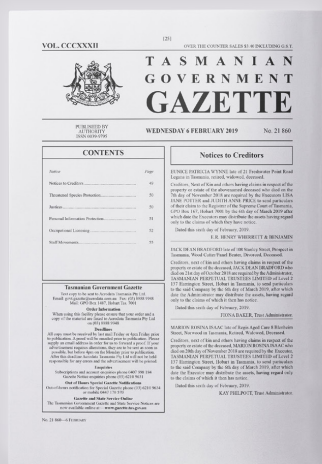

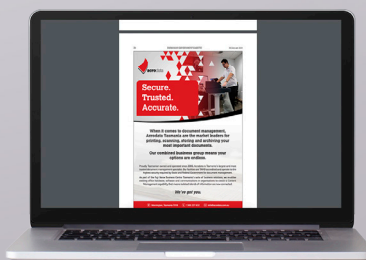
