Amendment of Fees under the Fee Units Act 1997

The *Fee Units Act 1997* (the Act) provides for automatic changes in Government fees and charges in accordance with movements in the Hobart Consumer Price Index. The Act also stipulates how fees are to be calculated and the process to follow in adjusting those fees.

In accordance with section 8A(3) of the Act, I give notice of the amendment of the previous notice, published on 29 March 2022, to correct the attached fees that have been previously tabled in Parliament.
