GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Proclamation under section 2 of the *Property Agents and Land Transactions Amendment Act 2020*

This proclamation fixes 4 May 2022 as the day on which the provisions of that Act commence.

(2) *Property Agents and Land Transactions Amendment Regulations 2022*

These regulations amend the *Property Agents and Land Transactions Regulations 2017* to –

- (a) rescind a provision, prescribing certain qualifications for certain licences, which is no longer required consequent on certain changes made to the *Property Agents and Land Transactions Act 2016*; and
- (b) update certain licence, and renewal, fees.
