I, Dr Ian Dutton, General Manager (Marine Resources) in the Department of Natural Resources and Environment, acting pursuant to a delegation from the Minister for Primary Industries and Water made on 13 July 2022 and acting pursuant to section 20(1) of the *Living Marine Resources Management Act 1995* (the Act), hereby determine under rule 11(1)(c) of the *Fisheries (Scalefish) Rules 2015* (the Rules):

- A. That the dates of the closed season for that part of the Scalefish fishery specified in schedule 1 are from:
 - 15 November 2022 to 14 December 2022 inclusive;
 - 15 November 2023 to 14 December 2023 inclusive;
 - 15 November 2024 to 14 December 2024 inclusive; and,
- B. That the dates of the closed season for that part of the Scalefish fishery specified in schedule 2 are from:
 - 15 January 2023 to 14 February 2023 inclusive;
 - 15 January 2024 to 14 February 2024 inclusive;
 - 15 January 2025 to 14 February 2025 inclusive; and
- C. That the parts of the Scalefish fishery specified in schedule 1 and schedule 2 are closed to, or in respect of, the activities specified in schedule 3.

SCHEDULE 1

All that part of the Scalefish Fishery in State waters adjacent to the east, west and south coasts of Tasmania south of:

- (a) in the west, an imaginary line starting at Cape Grim and then running due west along the line of latitude at 40°40'S to the limit of State waters; and
- (b) in the east, an imaginary line starting at Cape Naturaliste and then running due east along the line of latitude at 40°50'S to the limit of State waters.

This notice implements interim and urgent management actions relating to the non-commercial Scalefish Fishery to reduce fishing associated risks to the endangered Maugean Skate while a Conservation Action Plan is progressed. Fishers should note that although this notice closes Macquarie Harbour to gillnetting, an exemption instrument has been issued allowing non-commercial fishers (recreational and Aboriginal) to undertake gillnetting activities considered to be an acceptable risk to Maugean Skates. This includes gillnetting in defined areas between sun rise to two hours after sun set on the condition that gillnets are set less than two hours—i.e., net is retrieved and catch sorted.

 - g) an imaginary line that follows the high water mark in an approximately south-west direction from Gordon Point to latitude 42°26'06"S/longitude 145°27'28"E at Shamrock Point;
 - h) an imaginary straight line from latitude 42°26'06"S/longitude 145°27'28"E at Shamrock Point to latitude 42°26'17"S/longitude 145°26'49"E at the southernmost end of the beach below Henrietta Creek;
 - i) an imaginary line that follows the high water mark in an approximately north-west direction from latitude 42°26'17"S/longitude 145°26'49"E at the southernmost end of the beach below Henrietta Creek to Backagain Point;
 - j) an imaginary straight line from Backagain Point to latitude 42°14'44.1"S/longitude 145°17'14.7"E at the channel marker/navigation beacon;
 - k) an imaginary straight line from latitude 42°14'44.1"S/longitude 145°17'14.7"E to latitude 42°13'53.1"S/longitude 145°18'33.3"E at the channel marker/navigation beacon;
 - l) an imaginary straight line from latitude 42°13'53.1"S/longitude 145°18'33.3"E at the channel marker/navigation beacon to latitude 42°11'51"S/longitude 145°17'26.4"E on Neck Island;
