GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Passenger Transport Services Amendment Regulations 2022*

These regulations amend the *Passenger Transport Services Regulations 2013* by –

- (a) consolidating and incorporating provisions relating to the requirements and duties of certain passenger transport service operators and drivers; and
- (b) including application fees for affiliated operators and booking service providers; and
- (c) providing for the issue of infringement notices, and the penalties in relation to those notices.

(2) *Traffic (Compliance and Enforcement) Amendment (Passenger Transport) Regulations 2022*

These regulations amend the *Traffic (Compliance and Enforcement) Regulations 2017* by updating certain references to prescribed offences consequent on the making of the *Passenger Transport Services Amendment Regulations 2022*

(3) *Taxi Industry Amendment (Passenger Transport) Regulations 2022*

These regulations amend the *Taxi Industry Regulations 2018* by making amendments consequential on the commencement of –

- (a) certain provisions of the *On-Demand Passenger Transport Services Industry (Miscellaneous Amendments) Act 2020*; and
- (b) the *Passenger Transport Services Amendment Regulations 2022*.

(4) *Guardianship and Administration Amendment Regulations 2022*

These regulations amend the *Guardianship and Administration Regulations 2017* by –

- (a) prescribing health care, required under a direction given under section 42 of the *Public Health Act 1997*, as mandatory health care under section 35L of the *Guardianship and Administration Act 1995*; and
- (b) prescribing the manner in which, and specifying by whom, an application to register an advance care directive is to be made; and
- (c) prescribing the manner in which an advance care directive may be revoked; and
- (d) providing for the inspection of the register.

(5) *Misuse of Drugs Order 2022*

This order amends the *Misuse of Drugs Act 2001* by adding certain substances as controlled drugs for the purposes of that Act.

(6) Proclamation under section 2 of the *On-Demand Passenger Transport Services Industry (Miscellaneous Amendments) Act 2020*

This proclamation fixes 1 December 2022 as the day on which certain provisions of that Act commence.

(7) *Tasmanian Development Regulations 2022*

These regulations –

- (a) make provision in respect of powers and functions of directors, administrators and authorized officers of the Tasmanian Development Authority; and
- (b) are made consequentially on the repeal of the *Tasmanian Development Regulations 2012* under section 11 of the *Subordinate Legislation Act 1992*.

(8) Proclamation under section 2 of the *Homes Tasmania Act 2022*

This proclamation fixes 1 December 2022 as the day on which that Act commences.

(9) Proclamation under section 2 of the *Homes Tasmania (Consequential Amendments) Act 2022*

This proclamation fixes 1 December 2022 as the day on which Act commences.

(10) *Burial and Cremation Amendment Regulations 2022*

These regulations amend the *Burial and Cremation Regulations 2015* to amend the definition of "reportable death" and to remove certain references to deaths that may not have been due to natural causes.


