## PROCLAMATION

By His Excellency THE HONOURABLE ALAN MICHAEL BLOW, Officer of the Order of Australia, Lieutenant-Governor of the State of Tasmania and its Dependencies in the Commonwealth of Australia

WHEREAS by Letters Patent constituting the Office of Governor of the State of Tasmania and its Dependencies in the Commonwealth of Australia made at Hobart on 21 November 2005 under the Public Seal of the said State provision is made for the Lieutenant-Governor to assume and undertake the administration of the government of the said State in the event of a vacancy in the Office of Governor; the assumption by the Governor of the administration of the government of the Commonwealth of Australia; or the Governor, not having appointed a Deputy Governor, being for any reason unable to act as Governor

AND WHEREAS by Commission given at Hobart on 8 April 2013 under the Public Seal of the said State I, THE HONOURABLE ALAN MICHAEL BLOW, Officer of the Order of Australia, was appointed Lieutenant-Governor of the said State

AND WHEREAS the Governor of the said State THE HONOURABLE BARBARA BAKER, Companion of the Order of Australia, is unable to act as Governor for the period commencing at 12:00 noon on Sunday 24 December 2023 until 12:00 noon on Tuesday 23 January 2024 and has not appointed a Deputy Governor:

NOW THEREFORE I, THE HONOURABLE ALAN MICHAEL BLOW, Officer of the Order of Australia, Lieutenant-Governor of the said State having taken the Oaths directed by law to be taken by the Lieutenant-Governor in the manner prescribed do hereby notify and declare that, while the Governor of Tasmania is unable to act as Governor for the abovementioned period or until she is able to act, and while there is no Deputy Governor, I shall administer the government of the said State with all and singular the powers and functions of the Governor according to such Laws as are now or shall hereafter be in force in the said State.
