#### GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

- (1) Proclamation under section 2 of the *Occupational Licensing (Automatic Mutual Recognition Consequential Amendments) Act 2022*

This proclamation fixes 1 July 2023 as the day on which certain provisions of the *Occupational Licensing (Automatic Mutual Recognition Consequential Amendments) Act 2022* (being Parts 3 and 7) commence.

- (2) *Animal Welfare (General) Regulations 2023*

These regulations –

- (a) prescribe, for the purposes of the *Animal Welfare Act 1993* –
  - (i) certain requirements for ensuring the welfare of animals generally; and
  - (ii) matters relating to a rodeo Code of Practice; and
  - (iii) fees payable by certain institutions for an application to carry out animal research; and
- (b) are made consequentially on the repeal of the *Animal Welfare (General) Regulations 2013* under section 11 of the *Subordinate Legislation Act 1992*.

- (3) *Animal Welfare (Domestic Poultry) Regulations 2023*

These regulations –

- (a) prescribe, for the purposes of the *Animal Welfare Act 1993* –
  - (i) requirements for ensuring the health and welfare of domestic poultry in certain circumstances; and
  - (ii) infringement notice penalties; and
- (b) are made consequentially on the repeal of the *Animal Welfare (Domestic Poultry) Regulations 2013* under section 11 of the *Subordinate Legislation Act 1992*.

(4) *Animal Welfare (Pigs) Regulations 2023*

These regulations –

- (a) prescribe, for the purposes of the *Animal Welfare Act 1993* –
  - (i) requirements for ensuring the health and welfare of pigs in certain circumstances; and
  - (ii) matters relating to a Model Code of Practice for the Welfare of Animals: Pigs; and
  - (iii) infringement notice penalties; and
- (b) are made consequentially on the repeal of the *Animal Welfare (Pigs) Regulations 2013* under section 11 of the *Subordinate Legislation Act 1992*.

(5) *Vehicle and Traffic (Vehicle Operations) (Exemption) Notice 2023*

This notice, for the purposes of the *Vehicle and Traffic (Vehicle Operations) Regulations 2014*, exempts, for 3 years and for specified purposes, certain vehicles and combinations from the load limit applying to the Mud Walls Secondary Road between Tea Tree Secondary Road and the Midland Highway.

(6) *Animal Welfare (Transport of Livestock) Regulations 2023*

These regulations prescribe, for the purposes of the *Animal Welfare Act 1993*, transportation requirements for certain species of animal.

(7) *Marine and Safety (Infringement Notices) Amendment Regulations 2023*

These regulations amend the *Marine and Safety (Infringement Notices) Regulations 2017* by updating the Schedule of offences under the *Marine and Safety (General) Regulations 2023*.

(8) *Marine and Safety (General) Regulations 2023*

These regulations –

- (a) prescribe certain craft as vessels for the purposes of the *Marine and Safety Authority Act 1997*; and
- (b) provide for the wearing of approved personal flotation devices by persons on certain craft and by persons being towed by motor boats; and
- (c) prescribe mandatory safety equipment to be carried on lightweight craft; and
- (d) contain provisions relating to operating vessels at safe speeds and operating vessels in designated waters; and
- (e) provide for the wearing of life jackets on certain vessels and the maintenance of those life jackets; and
- (f) prescribe offences in respect of which infringement notices may be issued; and
- (g) rescind the *Marine and Safety (General) Regulations 2013*.



