### MOTOR VEHICLE TRADERS REGULATIONS 2022

#### *Used Motor Vehicle Pre-sale Disclosure Statement*

Notice is given that a Used Motor Vehicle Pre-sale Disclosure Statement has been approved for use by licensed motor vehicle traders. The Statement is to be completed by the trader and displayed prominently on any used motor vehicle offered for sale or exchange. A copy is also to be included in the contract of sale or exchange and it forms part of the contract.

The Statement must be used by traders from 1 April 2023.

## Gaming Control

### GAMING CONTROL ACT 1993

#### NOTICE

#### Prescribed duties in relation to special employees

The Tasmanian Liquor and Gaming Commission, established under section 123 of the *Gaming Control Act 1993*, acting pursuant to section 3(6) of the Act, hereby revokes the notice of the Tasmanian Gaming Commission made under section 3(6) of the Act and published in the Tasmanian Government Gazette on the 27th day of March 2013, and hereby specifies the following prescribed duties in relation to a special employee within the meaning of the Act. This takes effect from 1 July 2023.

**Where a person is employed or working, whether for remuneration or reward or not, for:**

**1. a licenced provider, except in an approved outlet or an approved location used to accept wagers by telecommunications devices, and undertakes the following duties:**

- 1.1. administration of a gaming activity and development of gaming activity policy;
- 2.2. supervision and control of the operations of wagering systems; or
- 3.3. management of fraud and integrity functions and systems.

**2. a casino operator, and undertakes the following duties:**

- 2.1. administration of gaming and development of gaming policy;
- 2.2. supervision and control of:
  - 2.2.1. table gaming;
  - 2.2.2. a cash desk/coin booth; and/or
  - 2.2.3. a premium player program;
- 2.3. inspection of table game operations;
- 2.4. dealing a table game;
- 2.5. undertaking or supervising the removal and movement of a table drop box;
- 2.6. accounting for the issuing, accepting or receiving chips; or
- 2.7. undertaking surveillance operations of table gaming.

**3. a keno operator or a monitoring operator, and undertakes the following duties:**

- 3.1. administration of gaming and development of gaming policy;
- 3.2. supervision, control and administration of:
  - 3.2.1. the conduct of games of keno;
  - 3.2.2. an electronic monitoring system; or
  - 3.2.3. core monitoring functions and/or regulated monitoring functions.





