SCHEDULE

1. The portion of Alberta Street in question forms part of 140 acres granted by the Crown to James Fenton by general law Purchase Grant 71-61 dated 1872
2. The Registry of Deeds general law owner’s indexes recited that James Fenton subdivided and conveyed numerous smaller lots from the above land over the years
3. By his will dated 5 June 1899 James Fenton appointed Bernard Shaw, Thomas Wilkes Monds and Magnus Medwin Smith as his executors and trustees. James Fenton died on 24 June 1901 and his will and codicil were subsequently proved in the Supreme Court where probate was granted on 8 August 1901 to the executors named in the will
4. By Indenture No 12-3394 dated 29 July 1910 Bernard Shaw and Thomas Wilkes Mondes retired as trustees and were replaced by new trustee Henry Owen Taylor Friend
5. Henry Owen Taylor Friend died on 9 September 1914
6. By Indenture No 13-4437 dated 28 September 1914 Magnes Medwin Smith appointed Lewis Arnold Emmett to become a joint trustee to the estate
7. The trustees disposed of various estate assets in 1931 by Conveyances No 18-5165, 18-8901, 18-9054, 18-9072 18-9074, 18—9078 & 18-9079
8. By Conveyance No 18-5165 dated 21 February 1931 the estate trustees conveyed unsold lots in and around Alberta Street to Archibald Claude Bauld as shown by a plan on the deed - as had apparently been agreed between the parties around the year 1914
9. A search did not find where either James Fenton or his personal representatives dealt with the road lines including Alberta Street however it was not unusual for residual road lines to remain in the general law parent deed in earlier times
10. Will No 20084 recites that Magnus Medwin Smith died on 25 March 1934
11. 11. Tasmanian Names Index on-line entry recites that Lewis Arnold Emmett was born on 15 September 1880 and Indenture No 18-5165 recites that had moved to reside in Victoria prior to 1931

From the above it would appear that the owner of the portion of Alberta Street between Percival Street and Stanley Street is the personal representatives of the estate of the late James Fenton (d1901) being a residue of land remaining in general law Purchase Grant No 71-61 (c1872).

There is no description for the Alberta Street land which will need to be surveyed to support an acquisition application by Council.
