

#### GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Electricity Supply Industry (Pricing and Related Matters) Regulations 2023*

These regulations –

- (a) provide for the regulation of prices set by certain electricity entities and other providers of certain other electrical services, the approval of certain types of contracts, the terms and conditions of certain types of contracts, and the methods by which the prices contained in such contracts are to be fixed; and
- (b) are made consequentially on the repeal of the *Electricity Supply Industry (Pricing and Related Matters) Regulations 2013* under section 11 of the *Subordinate Legislation Act 1992*.

(2) Proclamation under section 2 of the *Land Use Planning and Approvals Amendment Act 2022*

This proclamation fixes 17 May 2023 as the day on which the provisions of that Act commence.

(3) Proclamation under section 2 of the *Biosecurity Act 2019*

This proclamation fixes 17 May 2023 as the day on which the remaining provisions of that Act commence, other than Part 1 of Schedule 3.

(4) *State Service Amendment Regulations 2023*

These regulations amend the *State Service Regulations 2021* by including the position of State Litigator in the list of prescribed offices for the purposes of the *State Service Act 2000*.

(5) *Gaming Control Amendment Regulations 2023*

These regulations amend the *Gaming Control Regulations 2022* by –

- (a) defining ancillary gaming services for the purposes of the *Gaming Control Act 1993*; and
- (b) amending the licence fees payable by the holders of venue licences, casino licences and keno operator licences under that Act; and
- (c) requiring the former gaming operator to provide data to the Commission from the electronic monitoring system of the gaming operator; and
- (d) requiring the monitoring operator to conduct an audit of certain gaming machines before permitting their operation.

(6) Proclamation under section 2 of the *Education Legislation Amendments (Education Regulation) Act 2022*

This proclamation fixes 1 July 2023 as the day on which the provisions of that Act commence.
