## Threatened Species

### THREATENED SPECIES PROTECTION

Endorsed Changes to the Guidelines for Eligibility for Listing under the *Threatened Species Protection Act 1995* (the Guidelines)

The functions of the Scientific Advisory Committee (SAC) established under Section 8 of the *Threatened Species Protection Act 1995* include to advise the Minister and the Secretary on the listing and de-listing of taxa of flora and fauna. The SAC has a statutory responsibility for preparing guidelines on how the five criteria specified in Section 15 Eligibility for listing are to be applied to particular taxonomic groups.

The SAC recently endorsed an updated version of the Guidelines, and as such these changes improve the alignment of the Tasmanian threatened categories with the nationally agreed threatened categories required under the Common Assessment Method (CAM).
