LIVING MARINE RESOURCES MANAGEMENT ACT 1995

FISHERIES (ABALONE MANAGEMENT PLAN) ORDER 2024

I make the following order under section 48A of the *Living Marine Resources Management Act 1995*.

29 July 2024.

1. Short title
- This Order may be cited as the *Fisheries (Abalone Management Plan) Order 2024*.
2. Commencement
- This Order takes effect on the day on which it is published in the Gazette.
3. Rule 3 of *Fisheries (Abalone) Rules 2017* changed
- Rule 3 of the *Fisheries (Abalone) Rules 2017*\* is changed by omitting the definition of *quota limit* from subrule (1) and substituting the following definition:
- quota limit*, in respect of a fishing licence (abalone dive), means the amount of abalone that may be taken, at the particular time when the abalone is landed, from a part of the fishery in accordance with the licence;
- (Explanatory note)

This Order clarifies the management plan for the abalone fishery, as contained in the *Fisheries (Abalone) Rules 2017*, by clarifying the definition of quota limit as it applies in that fishery, including but not limited to, as it applies for the purposes of the over-catch provisions of the management plan.
