LIVING MARINE RESOURCES MANAGEMENT ACT 1995

SECTION 11

INSTRUMENT OF EXEMPTION

I, Deidre Wilson, Deputy Secretary in the Department of Natural Resources and Environment, acting pursuant to a delegation from the Minister administering the *Living Marine Resources Management Act 1995* (the Act), and acting pursuant to section 11 of the Act, hereby exempt the classes of persons specified in Schedule 1 from the determination made by the Minister on 19 August 2024 by the *Notice of the Dates of the Closed Season for Part of the Scalefish Fishery for Squid and Notice of Scalefish Fishery Closure to Specific Activities* (the Closure Notice) made pursuant to rule 11 of the *Fisheries (Scalefish) Rules 2015*, on the conditions specified in Schedule 2.

This exemption takes effect from 12:01 am on 1 September 2024 and remains in force until 11:59 pm on 14 November 2026.

SCHEDULE 1

Classes of Persons

1. The persons holding a Commonwealth authority; and
2. The persons holding a Tasmanian fishing licence (automatic squid jig); and
3. A person to whom condition 3 in Schedule 2 applies; and
4. A person to whom condition 4 in Schedule 2 applies.

SCHEDULE 2

Conditions

- 1) The holder of a Commonwealth authority may possess of Gould's squid that were taken under that Commonwealth authority.
- 2) The holder of a Tasmanian fishing licence (automatic squid jig) may possess Gould's squid that were taken under the authority of that licence in State waters.
- 3) A person may possess of squid (whole or part) where the person possessing the squid can establish that the squid was purchased from a commercial supplier or was taken by the holder of a fishing licence (personal) in an open season and open area.
- 4) A person may transit the closed areas specified in schedule 1 and 2 of the Closure Notice whilst in possession of squid species taken outside of the closed area.

Any expression used in bearing a particular meaning under the Act or the Rules has the same meaning in the Schedule as it has in the Act or the Rules.
