In accordance with the provisions of the Rules Publication Act 1953, notice is given of the making of the following statutory rules:-

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Work Health and Safety (Crystalline Silica Substances) Amendment Regulations 2024

These regulations amend the *Work Health and Safety Regulations 2022* to impose obligations on a person conducting a business or undertaking who carries out high-risk crystalline silica processes, including to -

- (a) provide instruction, information and training to workers; and
- (b) develop a silica risk control plan; and
- (c) monitor air quality at workplaces and the health of workers.
- (2) Proclamation under section 2 of the *Container Refund Scheme Act 2022*

This proclamation fixes 27 August 2024 as the day on which provisions of that Act, relating to certain scheme participants, commence.

(3) Proclamation under section 2 of the *Guardianship and Administration Amendment Act 2023*

This proclamation fixes 1 September 2024 as the day on which the provisions of that Act commence.

(4) Guardianship and Administration Amendment Regulations 2024

These regulations amend the Guardianship and Administration Regulations 2017 -

- (a) in relation to information required in support of applications under the Guardianship and Administration Act 1995; and
- (b) to prescribe speech pathologists as health practitioners for the purposes of Part 5A of that Act; and
- (c) in relation to the complaint processes to be followed by the Public Guardian and the Public Trustee.
