RULES PUBLICATION ACT 1953

NOTICE OF THE MAKING OF STATUTORY RULES

In accordance with the provisions of the *Rules Publication Act 1953*, notice is given of the making of the following statutory rules:-

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Variation of Trusts Regulations 2024*

These regulations –

- (a) for the purposes of the *Variation of Trusts Act 1994* –
  - (i) prescribe the maximum dollar amount for property that a charitable trust may hold before the trust is unable to apply for a variation of the purposes for which the property is required or permitted to be applied under a charitable trust; and
  - (ii) prescribe the form of that application; and
  - (iii) make provision for certain matters pertaining to a register kept under the Act; and
- (b) are made consequentially on the repeal of the *Variation of Trusts Regulations 2014* under section 11 of the *Subordinate Legislation Act 1992*.

(2) *Bail Regulations 2024*

These regulations –

- (a) provide for the forms to be used on admission to police bail, for a warrant of arrest, for a bail document or recognizance or for various applications under the *Bail Act 1994*; and
- (b) provide that an application under section 20(d) of the Act is to be served personally, and the manner in which the proof of such service is to be provided to the court; and
- (c) prescribe that an affidavit is to accompany certain applications; and
- (d) are made consequentially on the repeal of the *Bail Regulations 2014* under section 11 of the *Subordinate Legislation Act 1992*.
