# WASTE AND RESOURCE RECOVERY (EXCLUSION OF ENGINEERED STONE) ORDER 2024

I make the following order under section 6 of the Waste and Resource Recovery Act 2022.

#### 1. Short title

This order may be cited as the Waste and Resource Recovery (Exclusion of Engineered Stone) Order 2024.

#### 2. Commencement

This order takes effect on the day on which it is published in the Gazette.

#### 3. Interpretation

(1) In this order -

Act means the Waste and Resource Recovery Act 2022; engineered stone has the same meaning as in the Work Health and Safety Regulations 2022.

(2) The *Acts Interpretation Act 1931* applies to the interpretation of this order as if this order were regulations.

#### 4. Matter to be excluded

For the purposes of section 28(a) of the Act, bench tops, panels and slabs consisting of engineered stone are declared to be matter that is excluded from Part 3 of the Act

#### 5. Expiry

This order expires on 30 June 2025.

# Explanatory Note

This order excludes engineered stone from the provisions of Part 3 of the *Waste and Resource Recovery Act 2022*.

#### GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Housing Land Supply (Penguin) Order 2024

This order, for the purposes of the Housing Land Supply Act 2018, declares -

- (a) a certain area of land situated at Lester Road, Penguin in Tasmania to be housing supply land; and
- (b) the intended zone in relation to that land to be the General Residential Zone referred to in the applicable planning scheme.

This order, for the purposes of the Housing Land Supply Act 2018, declares –

- (a) a certain area of land at William Street, Brighton, to be housing supply land; and
- (b) the intended zone in relation to that land to be the General Residential Zone referred to in the applicable planning scheme.
- (3) Mines Work Health and Safety (Supplementary Requirements) Amendment Regulations 2024

These regulations amend the *Mines Work Health and Safety (Supplementary Requirements) Regulations 2022* by postponing the expiry of those regulations until 30 June 2025.

(4) Proclamation under section 2 of the Historic Cultural Heritage Amendment Act 2024

This proclamation fixes 1 January 2025 as the day on which the provisions of that Act commence.

(5) Proclamation under section 2 of the Evidence (Children and Special Witnesses) Amendment Act 2024

This proclamation fixes 31 January 2025 as the day on which the provisions of that Act commence.

(6) Threatened Species Protection Amendment Regulations 2024

These regulations amend the Threatened Species Protection Regulations 2016 by -

- (a) altering a definition to explicitly allow for the relocation or release of threatened species of flora and fauna into the wild; and
- (b) replacing a form relating to the nomination for listing or de-listing of threatened species.
- (7) Proclamation under section 2 of the Health Complaints Amendment (Code of Conduct) Act 2018

This proclamation fixes 31 December 2024 as the day on which that Act commences.

(8) Registration to Work with Vulnerable People Amendment Regulations 2024

These regulations amend the Registration to Work with Vulnerable People Regulations 2024 by omitting certain exemptions from the requirement to be registered to engage in a child-related activity.

(9) Land Use Planning and Approvals (Application of Act) Regulations 2024

These regulations -

- (a) exclude certain activities from the definition of development in the Land Use Planning and Approvals Act 1993; and
- (b) are made consequentially on the repeal of the Land Use Planning and Approvals (Application of Act) Regulations 2014 under section 11 of the Subordinate Legislation Act 1992.
- (10) Building and Construction Industry Training Fund Regulations 2024

These regulations -

- (a) prescribe, in relation to the levy for building or construction work under the Building and Construction Industry Training Fund Act 1990
  - (i) the procedure for issuing a voucher or receipt on payment of the levy; and
  - (ii) the requirements for giving notice of cancellation of that work; and
  - (iii) the requirements to provide information, or keep records, in respect of the levy or that work; and
- (b) are made consequentially on the repeal of the Building and Construction Industry Training Fund Regulations 2014 under section 11 of the Subordinate Legislation Act 1992.
- (11) Land Use Planning and Approvals Regulations 2024

These regulations -

- (a) provide for the advertisement of certain exhibitions under the Land Use Planning and Approvals Act 1993; and
- (b) prescribe the notice requirements for certain exhibitions, approvals and applications under that Act; and
- (c) prescribe certain offences, penalties and fees payable under that Act; and
- (d) are made consequentially on the repeal of the Land Use Planning and Approvals Regulations 2014 under section 11 of the Subordinate Legislation Act 1992.

(12) State Policies and Projects Regulations 2024

These regulations -

- (a) prescribe the requirements for the advertising of draft State Policies and draft integrated assessment reports; and
- (b) prescribe the requirements for the making, and the content, of certain notices; and
- (c) are made consequentially on the repeal of the State Policies and Projects Regulations 2014 under section 11 of the Subordinate Legislation Act 1992.
