# Residential Building Works and Dispute Resolution

Residential Building Work Contracts and Dispute Resolution Act 2016

## **Residential Building Consumer Guide**

Notice is given that the Director of Building Control on 26 June 2024 approved a Residential Building Consumer Guide under section 81 of the *Residential Building Work Contracts and Dispute Resolution Act 2016* ("the Act").

- The Residential Building Consumer Guide is required to be given by a building contractor to an owner before entering a residential building contract for a contract price of \$20,000 or more. It contains information about the operation of the Act and basic information for owners or consumers about building contracts and the building process, and the resolution of disputes.
- The Guide is published by the Director of Building Control. It was last made in 2016.
- Amendments of the Act have required the Director to rescind the current Guide, effective on 2 July 2024.
- An approved Residential Building Consumer Guide, reissued with alterations, will take effect on 3 July 2024 and supersedes all previous consumer guides in relation to residential building work.


