## Gaming Control

*Gaming Control Act 1993*  
Ministerial Direction

To: Tasmanian Liquor and Gaming Commission

I give you the following Direction under section 127 of the *Gaming Control Act 1993*.

**Title**

This Direction may be cited as the *Tasmanian Liquor and Gaming Commission Ministerial Direction (No.2) 2024*.

**Commencement**

That the Direction take effect on the date it is gazetted.

**Direction**

The Tasmanian Liquor and Gaming Commission is to:

1. declare, by notice in the Gazette, that social poker is an exempt game under section 3(8A) of the *Gaming Control Act 1993*;
2. include in the notice under section 3(8A) of the *Gaming Control Act 1993* any appropriate conditions to which the declaration is subject and any appropriate conditions relating to the conduct of the exempt game of social poker, with such conditions to include;
  - a. that social poker may only be played in a tournament structure under which the cost to participate must not exceed the value of a single entry fee and a single re-entry fee, and no further charges are levied on participants during the tournament;
  - b. that all participants must pay the same entry fee, which must not exceed \$250;
  - c. that all participants must pay the same re-entry fee, which must be equal to the value of the original entry fee;
  - d. that all participants must be given an equal number and value of poker chips per entry fee and re-entry fee, and that no participant may purchase or otherwise be supplied with additional poker chips before or during the tournament;
  - e. that the poker chips used must have no monetary value during the tournament and must only be used to determine the overall winner or winners of the tournament, such that poker chips are not redeemable for monetary value or any other benefit;

- f. that the operators of a social poker tournament must make the rules of the tournament available to all participants, and that those rules must include sufficient information to enable participants to reasonably understand the game;
- g. that the operators of a social poker tournament must reasonably make participants aware of the available prizes, and how the prizes will be distributed to the winner or winners of the tournament, in advance;
- h. that the value of the prizes in a social poker tournament must be determined before the completion of the tournament;
- i. that the cash value or equivalent retail value of all prizes for any social poker tournament must be no less than 70 per cent of the total proceeds generated from entry and re-entry fees;
- j. that a social poker tournament must only be conducted in a licensed premises; and
- k. that the operators of a social poker tournament are required to undertake Responsible Conduct of Gambling training.

The declaration should be made by the Tasmanian Liquor and Gaming Commission within 60 days of this Direction.

A review relating to the conduct of social poker as an exempt game should be undertaken by the Tasmanian Liquor and Gaming Commission within 18 months of this Direction.


