

Personal Information Protection

PERSONAL INFORMATION PROTECTION ACT 2004 EXEMPTION UNDER SECTION 14

I, Guy Barnett MP, Minister for Justice, being and as the Minister responsible for the administration of the *Personal Information Protection Act 2004* ("the Act"), upon being satisfied that the public benefit in doing so outweighs to a substantial degree the public benefit from compliance with the Personal Information Protection Principles, hereby approve an application dated 27 May 2024 made under section 13 of the Act by the Department of Premier and Cabinet for an exemption from compliance with the Act, subject to the following conditions:

- 1. That any information, but for this exemption, that would be protected by the Act held by the Government Departments named in Part 1, Schedule 1 of the State Service Act 2000 can be disclosed to Mr Peter Woolcott AO for the purpose of conducting the review known as the Independent Review into the actions taken in response to the information and concerns raised by the Commission of Inquiry into the Tasmanian Government's Responses to Child Sexual Abuse in Institutional Settings;
- That the purposive exemption above extend to any other person retained by (or employed in conjunction with) the said Mr Woolcott for the purpose of progressing the said independent review;
- 3. That information can only be shared pursuant to the above exemption whereby such information is, or has the potential to be, relevant to the said review;
- 4. That in determining whether information is, or has the potential to be, relevant to the independent review, regard must be given to the Terms of Reference establishing the review; and
- 5. That if information is shared pursuant to this exemption that is not relevant and is not potentially relevant to the aforementioned independent review, it will be returned or otherwise actioned as per the election of the relevant department, and in compliance with the *Archives Act 1983*. This does not include information that may become relevant to the independent review that should be retained so as to preserve the integrity of a record as a whole, or for similar or related purposes.

Details of the Application

The Department of Premier and Cabinet has applied under Section 13 of the *Personal Information Protection Act 2004* ("the Act") for an exemption under Section 14 of the Act to allow for information within its custody and control to be disclosed and used by Mr Peter Woolcott AO for the purpose of undertaking a *Review of the actions taken in response to the information and concerns raised by the Commission of Inquiry into the Tasmanian Government's Responses to Child Sexual Abuse in Institutional Settings.*

The exemption is to ensure that all information relevant to independent review can be obtained by the independent reviewer, and utilised within the constraints of the law, whilst still protecting the privacy of individuals.

- (c) authorises pharmacists to possess, sell, supply and prescribe certain scheduled substances in certain circumstances; and
- (d) is in effect for 6 months.




