## DECLARATION OF PROHIBITED MATTER

*Biosecurity Act 2019*

## Section 20

1. I, Noel Carmichael, being and as the A/Manager of the Invasive Species Branch of the Department of Natural Resources and Environment Tasmania, and delegate of the Minister for Primary Industries and Water under the *Biosecurity Act 2019* (the Act), acting under section 20 of the Act, **hereby declare** the biosecurity matter or classes of biosecurity matter listed in **Schedule 1** below as prohibited matter, being satisfied that –
  - (a) the biosecurity matter or classes of biosecurity matter pose a significant biosecurity risk to Tasmania; and
  - (b) the declaration is necessary to prevent, eliminate, minimise, control or manage the biosecurity risk posed by the biosecurity matter or class of biosecurity matter.
2. This declaration is subject to the following provisions:
  - (a) any biosecurity matter that becomes prohibited matter because of this declaration may be lawfully disposed of, treated or destroyed –
    - (i) in accordance with a prohibited matter permit issued under the Act; or
    - (ii) in accordance with any biosecurity direction issued under the Act; or
    - (iii) under the supervision or direction of an authorised officer;
  - (b) section 74 of the Act does not apply in respect of the disposal, treatment or destruction of any biosecurity matter under paragraph (a) above.
3. Declaration takes effect on the date of its publication in the Gazette and remains in force until revoked.


