- (1) Proclamation under section 2 of the *Child Safety Reform Implementation Monitor Act 2024*This proclamation fixes 6 November 2024 as the day on which that Act commences.
- (2) Child Safety Reform Implementation Monitor Regulations 2024

These regulations prescribe, for the purposes of the *Child Safety Reform Implementation Monitor Act 2024*, the registration required to be held by, and the checks required to be completed for, a person to be appointed as the Child Safety Reform Implementation Monitor under that Act.

(3) Proclamation under section 2 of the *Firearms Amendment (Community Safety) Act 2023*This proclamation fixes 1 December 2024 as the day on which the remaining provisions of that Act commence.

(4) Rail Infrastructure (Rail Network) Order 2024

This order -

- (a) removes from the rail network under the *Rail Infrastructure Act 2007* that portion of the South Line designated in Plan No. 11477 in the Central Plan Register; and
- (b) revokes the designation of Tasmanian Railway Pty Ltd as the Rail Infrastructure Owner in respect of that portion of railway; and
- (c) transfers ownership of the associated rail infrastructure to the Crown.


