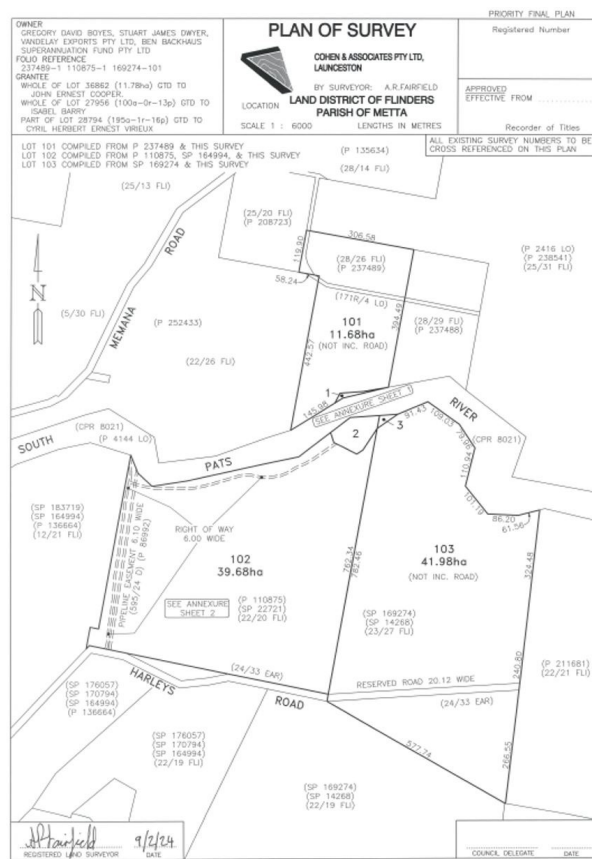

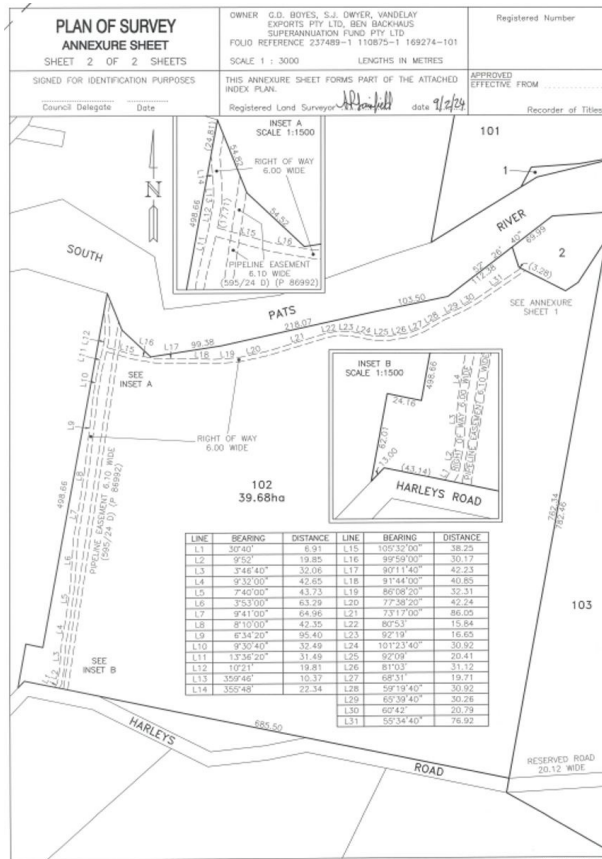
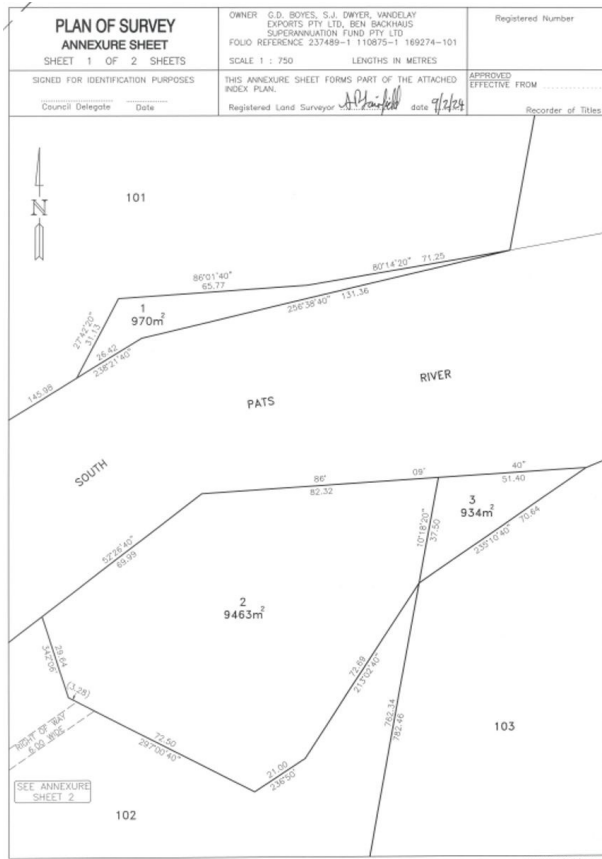

## Personal Information Protection

### PERSONAL INFORMATION PROTECTION ACT 2004

#### EXEMPTION UNDER SECTION 14

I, Guy Barnett, Minister for Justice, being and as the Minister responsible for the administration of the *Personal Information Protection Act 2004* ("the Act"), upon being satisfied that the public benefit in doing so outweighs to a substantial degree the public benefit from compliance with the Personal Information Protection Principles, hereby approve an application dated 18 September 2024 made under sections 13 and 14 of the Act by the Department of State Growth ("the Department") for an exemption from compliance with the Act, subject to the following conditions:

1. That any information that would be protected by the Act can be disclosed to the Secretary of the Department of Police, Fire and Emergency Management; the Secretary of the Department for Education, Children and Young People; the Minister for Children and Youth; and the Integrity Commission, as appropriate, and for the purpose of investigating and acting on possible breaches of the State Service Code of Conduct or other laws, that has been identified pursuant to employment investigations conducted by the Department of State Growth following the Commission of Inquiry into the Tasmanian Government's Responses to Child Sexual Abuse in Institutional Settings.
2. That information can only be shared whereby such information is, or has the potential to be, relevant to the roles, functions and powers of the above listed entities; and
3. That if information is shared pursuant to this exemption that is not relevant to the roles, functions and powers of the above listed entities, it will be returned to the Department of State Growth, and in compliance with the *Archives Act 1983*.

#### Details of the Application

The Department of State Growth ('the Department') has applied under Section 13 of the *Personal Information Protection Act 2004* ('the Act') for an exemption under Section 14(1)(a) of the Act to allow for the use and disclosure of personal information without consent of the person to whom the information relates.

Following the conclusion of the *Commission of Inquiry into the Tasmanian Government's Responses to Child Sexual Abuse in Institutional Settings* ('Commission'), the Department of State Growth considered the Commission's report to determine whether any departmental employee may have breached the State Service Code of Conduct ('the Code') or other Tasmanian laws.

The exemption is to ensure that the appropriate authorities and responsible persons can effectively be advised of any potential breaches of the Code or other Tasmanian laws.

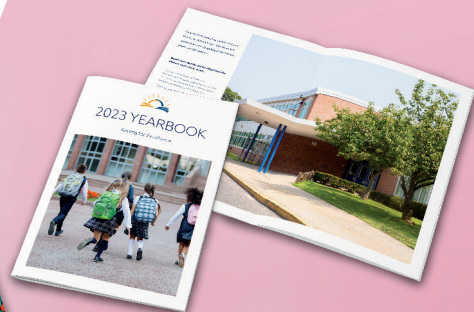
