GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Primary Produce Safety (Dairy) Regulations 2024

These regulations prescribe, for the purposes of the Primary Produce Safety Act 2011 -

- (a) the food safety scheme in respect of dairy products; and
- (b) that the Tasmanian Dairy Industry Authority is designated to perform certain roles of the Chief Inspector for the purposes of the dairy food safety scheme; and
- (c) the accreditation requirements in respect of the dairy food safety scheme; and
- (d) the fees payable in respect of accreditation under the Act; and
- (e) other miscellaneous matters in relation to dairy products.
- (2) Traffic (Compliance and Enforcement) Amendment (Vehicle and Traffic) Regulations 2024

These regulations amend the *Traffic (Compliance and Enforcement) Regulations 2017* by updating references consequential on the commencement of the *Vehicle and Traffic (Vehicle Operations) Regulations 2024* and the *Vehicle and Traffic (Vehicle Standards) Regulations 2024*.

- (3) Proclamation under section 2 of the *Residential Building (Miscellaneous Consumer Protection Amendments) Act 2023* This proclamation fixes 1 October 2024 as the day on which Parts 2, 3, 4, 5 and 8 of that Act commence.
- (4) Agricultural and Veterinary Chemicals (Tasmania) Regulations 2024

These regulations -

- (a) declare the Agricultural and Veterinary Chemicals (Control of Use) Act 1995 to be an eligible law for the purposes of the Agvet Code of Tasmania; and
- (b) specify that the Poisons Act 1971 has effect despite that Code; and
- (c) are made consequentially on the repeal of the Agricultural and Veterinary Chemicals (Tasmania) Regulations 2014 under section 11 of the Subordinate Legislation Act 1992.

(5) Archives Regulations 2024

These regulations -

- (a) provide for the general management and control of the Archives Office; and
- (b) provide for the use of, and access to, State archives; and
- (c) provide for the copying of State archives; and
- (d) provide for the procedure regarding records of State and local authorities that have been abolished, amalgamated or had their functions terminated; and
- (e) are made consequentially on the repeal of the Archives Regulations 2014 under section 11 of the Subordinate Legislation Act 1992.
- (6) Proclamation under section 7 of the Roads and Jetties Act 1935

This proclamation -

- (a) declares portions of certain roads to be State highways; and
- (b) amends a prior proclamation (Statutory Rules 1970, No. 67) by redefining the West Tamar Highway; and
- (c) partially revokes a certain spent proclamation in respect of the West Tamar Highway.
- (7) Proclamation under section 52A of the Roads and Jetties Act 1935

This proclamation, for the purposes of section 52A of the Roads and Jetties Act 1935 –

- (a) clarifies a previously declared limited access road in relation to certain portions of the West Tamar Highway; and
- (b) declares portions of certain roads to be places of access for the West Tamar Highway; and
- (c) revokes a previous proclamation in relation to the West Tamar Highway.


