Notice of the making of a reserve price determination for owner-operator taxi licences

The *Taxi and Hire Vehicle Industries Act 2008* requires the Tasmanian Economic Regulator to make a reserve price determination for Owner-operator Taxi Licences (OOTLs) for each taxi area in Tasmania.

This notice serves to advise that the determination has been made. A copy of the determination, which is included in the Tasmanian Economic Regulator's *Owner-operator Taxi Licence Reserve Price Determination Final Report,* is available at www.economicregulator.tas.gov.au/taxis.

The determination sets out the reserve (minimum) prices that new OOTLs can be purchased from the Transport Commission under an annual tender process for the period 1 January 2026 to 31 December 2029 for each taxi area in Tasmania.

The reserve prices for new OOTLs for each of the 24 taxi areas, and start date for each reserve price in the determination, are as follows:
