GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Road Amendment (Helmets) Rules 2025*

These rules amend the *Road Rules* by providing an exemption for members of religious groups from the requirement to wear an approved bicycle helmet in certain circumstances.

(2) *Traffic (Compliance and Enforcement) Amendment (Helmets) Regulations 2025*

These regulations amend the *Traffic (Compliance and Enforcement) Regulations 2017* by effecting minor statute law revision to certain regulations consequent upon amendments made to the *Road Rules*.

(3) *Tasmanian Civil and Administrative Tribunal Amendment (Fees) Regulations 2025*

These regulations amend the *Tasmanian Civil and Administrative Tribunal Regulations 2021* by –

- (a) prescribing certain fees that are payable in relation to proceedings before the Tribunal; and
- (b) effecting minor statute law revision.

(4) *Security and Investigations Agents Regulations 2025*

These regulations –

- (a) prescribe infringement offences for the purposes of the *Security and Investigations Agents Act 2002* and the penalties payable for those offences; and
- (b) prescribe certain fees payable under that Act; and
- (c) are made consequentially on the repeal of the *Security and Investigations Agents Regulations 2015* under section 11 of the *Subordinate Legislation Act 1992*.

(5) *Industrial Relations Regulations 2025*

These regulations –

- (a) provide, for the purposes of the *Industrial Relations Act 1984* –
 - (i) directions in relation to, and the recording of, proceedings before the Tasmanian Industrial Commission; and
 - (ii) various forms in respect of awards, industrial agreements and enterprise agreements under that Act; and
 - (iii) various other matters arising under that Act; and
- (b) are made consequentially on the repeal of the *Industrial Relations Regulations 2015* under section 11 of the *Subordinate Legislation Act 1992*.

(6) *Passenger Transport Services Amendment (Common Ticketing) Regulations 2025*

These regulations amend the *Passenger Transport Services Regulations 2023* by –

- (a) providing for the use of contactless payment methods to pay fares in respect of regular passenger services; and
- (b) specifying the obligation of a passenger, in certain circumstances, to scan on and off during a journey on a regular passenger service; and
- (c) providing for the use of revenue protection devices by authorised officers in respect of fare evasion; and
- (d) updating the list of infringement notice offences.

(7) *Community Protection (Offender Reporting) Regulations 2025*

These regulations –

- (a) prescribe classes of police officers as authorised persons; and
- (b) prescribe laws of foreign jurisdictions as corresponding Acts; and
- (c) prescribe classes of orders as corresponding offender reporting orders; and
- (d) prescribe orders under the *Criminal Justice (Mental Impairment) Act 1999* as sentences; and
- (e) prescribe authorities as the supervising authorities of classes of reportable offenders; and
- (f) specify foreign witness-protection laws and corresponding Acts for the purposes of section 40(2) of the *Community Protection (Offender Reporting) Act 2005*; and
- (g) prescribe entities for the purposes of information disclosure; and
- (h) are made consequentially on the repeal of the *Community Protection (Offender Reporting) Regulations 2016* under section 11 of the *Subordinate Legislation Act 1992*.

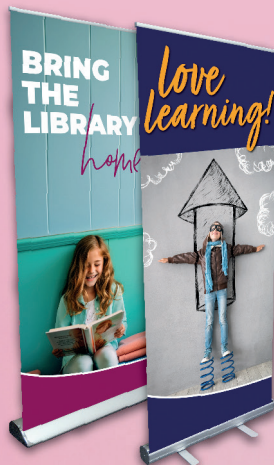
