RULES PUBLICATION ACT 1953

NOTICE OF THE MAKING OF STATUTORY RULES

In accordance with the provisions of the *Rules Publication Act 1953*, notice is given of the making of the following statutory rules:-

(3) <i>Roads and Jetties Act 1935</i>	S. R. 2025, No. 5	Proclamation under section 52A

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

- (1) *Electoral Regulations 2025*
These regulations –
- (a) prescribe the contents of writs for elections; and
 - (b) prescribe the printing order for names on batches of ballot papers subsequent to the first batch; and
 - (c) are made consequentially on the repeal of the *Electoral Regulations 2025* under section 11 of the *Subordinate Legislation Act 1992*.
- (2) *Prepaid Funerals Regulations 2025*
These regulations –
- (a) exempt certain deposits schemes and certain classes of prepaid funerals agreements from the application of certain provisions of the *Prepaid Funerals Act 2004*; and
 - (b) are made consequentially on the repeal of the *Prepaid Funerals Regulations 2015* under section 11 of the *Subordinate Legislation Act 1992*.

(3) Proclamation under section 52A of the *Roads and Jetties Act 1935*

This proclamation –

- (a) sets forth a place of access in relation to the limited access road known as the Brooker Highway; and
- (b) amends an earlier proclamation (S.R. 1978, No. 282) in relation to the Brooker Highway by –
 - (i) inserting in that earlier proclamation, the place of access set forth in this proclamation; and
 - (ii) removing a place of access from that earlier proclamation.
