## Personal Information Protection

PERSONAL INFORMATION PROTECTION ACT 2004

EXEMPTION UNDER SECTION 14

I, Guy Barnett, Minister for Justice, being and as the Minister responsible for the administration of the *Personal Information Protection Act 2004* ("the Act"), upon being satisfied that the public benefit in doing so outweighs to a substantial degree the public benefit from compliance with the Personal Information Protection Principles, hereby approve an application dated 7 November 2024 made under section 13 of the Act by the Department of Health, the Tasmanian Health Service and Ambulance Tasmania for an exemption from compliance with section 17 and with respect to the principles in clauses 1, 2, 7 and 10 of Schedule 1 of the Act, subject to the following conditions:

1. With respect to the Tasmanian Health Service and Ambulance Tasmania the exemption is limited to disclosure of personal information to the Department of Health where the disclosure is for one of the following purposes:
  - a. to create de-identified data relating to state and national health indicators;
  - b. the investigation of complaints about the provision of services by the Tasmanian Health Service or Ambulance Tasmania; and
  - c. to respond to concerns about abuse in care ('the exemption purposes').
2. With respect to the Department of Health, the exemption is limited to collection and use of personal information for the exemption purposes.
3. Personal information collected or used by the Department of Health pursuant to this exemption that is found to be irrelevant or redundant for the exemption purposes will, as per the election of the personal information custodian of origin, either be returned or destroyed in compliance with the *Archives Act 1983*. This does not include personal information that in the future may become relevant to one of the exemption purposes.

### Details of the Application

The Department of Health, the Tasmanian Health Service and Ambulance Tasmania have applied under Section 13 of the *Personal Information Protection Act 2004* ("the Act") for an exemption under Section 14 of the Act to allow for information within the custody and control of the Tasmanian Health Service and Ambulance Tasmania to be disclosed and used by the Department of Health.

The exemption is to ensure that information held by the Tasmanian Health Service and Ambulance Tasmania may be used and disclosed by the Department of Health for state and national health indicators, the investigation of health complaints or responding to requests for information from programs like the National Redress Scheme.

#### PERSONAL INFORMATION PROTECTION ACT 2004 EXEMPTION UNDER SECTION 14

I, Guy Barnett, Attorney General and Minister for Justice, being and as the Minister responsible for the administration of the *Personal Information Protection Act 2004* ("the Act"), upon being satisfied that the public benefit in doing so outweighs to a substantial degree the public benefit from compliance with Personal Information Protection Principles, hereby approve an application dated 29 November 2024 made under section 13 of the Act by the Department of Premier and Cabinet (the Department) for an exemption from compliance with section 17 of the Act, with respect to the principles in clauses 1 and 10 of Schedule 1 to the Act, subject to the following conditions:

1. The exemption is limited to the collection of personal information and sensitive information entered into nomination forms for the "Graces Awards" in respect of nominees who are over the age of 18.
2. The Department's collection of personal information and sensitive information must comply with the Personal Information Protection Procedures submitted with the application dated 29 November 2024 by the Secretary of the Department.
3. If sensitive information is collected about a nominee whose nomination is unsuccessful, the sensitive information is to be destroyed in compliance with the *Archives Act 1983*. This does not include basic personal information collected about the nominee.

### Details of Application

The Department of Premier and Cabinet has applied under Section 13 of the *Personal Information Protection Act 2004* ("the Act") for an exemption under Section 14 of the Act to allow for the collection of personal information and sensitive information without the consent or knowledge of the person to whom the information relates.

The Department is launching a new award to recognise and celebrate the incredible potential, contributions, and/or achievements of Young Tasmanian women. Upon the recommendation of the Tasmanian Women's Council, the awards will be named in honour of Grace Tame ("the Graces").

People over 18 years of age may be nominated with their knowledge or consent. The information collected would be solely used for the purpose of assessing the Graces nominations.

The exemption is to ensure that information about nominees can be collected without their knowledge or consent. The purpose of the exemption is to enable nominations of young Tasmanian women, including those with a trans and/or non-binary experience over 18, who may not otherwise self-nominate and who are the type of role models the awards wishes to recognise.


