PUBLIC NOTICE – TOTAL ALLOWABLE CATCH FOR THE COMMERCIAL BANDED MORWONG FISHERY FOR THE 2025-2026 QUOTA PERIOD

I, ERIC ABETZ MP, Minister for Business, Industry and Resources administering the *Living Marine Resources Management Act 1995* (the Act), acting pursuant to Section 94 of the Act, for the quota period 1 March 2025 to 28 February 2026, hereby determine that:

- a) The Total Allowable Catch for the commercial banded morwong fishery be set at 33.376 tonnes;
- b) The part of the commercial banded morwong fishery from which the Total Allowable Catch is to be taken is the “TAC area” as defined in the Fisheries (Scalefish) Rules 2015; and
- c) The Total Allowable Catch equates to 28 kilograms per quota unit.

Words and expressions used in this Public Notice have the same meaning as in the *Living Marine Resources Management Act 1995* and the *Fisheries (Scalefish) Rules 2015*.
