FOREWORD

A review of the May 2010 Farm Dairy Premises Effluent Management Code of Practice was undertaken following extensive consultation with dairy industry representatives (including dairy farmers) and relevant State authorities during 2024/25. This Code of Practice has been updated to reflect changes in the industry's approach to effluent management since that time.

The Farm Dairy Premises Effluent Management Code of Practice 2025 (the Code) represents a further step towards ensuring that appropriate farm dairy premises effluent management is undertaken and maintained in the State. The adoption of this Code by the Tasmanian Dairy Industry Authority (TDIA) is not intended to substitute or interfere with the role of environmental regulators responsible for enforcing compliance with *Environmental Management and Pollution Control Act 1994* (EMPCA). Rather, it is intended to assist those authorities by reducing the likelihood of dairy effluent presenting as environmental problems.

PURPOSE

The purpose of this Code is to ensure that effluent from a dairy premises is managed in a way which is not likely to have an unacceptable impact on the environment. Dairy farmers, like all members of society, have a duty not to pollute the environment and the effluent from a dairy animal in a premises should not present any greater risk to the environment than the effluent from a dairy animal on pasture.

CONTENT

This Code consists of a statement of the outcomes and specific requirements which must be met by operators of a dairy premises. Attached to the Code is a brief explanation of how enforcement of the Code is managed.

LEGISLATION

This Code is made pursuant to Part 5 of the *Dairy Industry Act 1994* and operators of dairy premises must comply with its requirements. Compliance with this Code should reduce the potential for environmental harm or environmental nuisance as defined by the *Environmental Management and Pollution Control Act 1994* (EMPCA).

ACKNOWLEDGEMENT

This Code was developed by the Tasmanian Dairy Industry Authority (TDIA) in collaboration with the Effluent Management Stakeholder Reference Group, comprising industry representatives and other relevant state authorities. TDIA would like to acknowledge all Tasmanian individuals and organisations, including Tasmanian dairy farmers, who provided feedback during the stakeholder consultation period.

DEFINITIONS

(for the purposes of this Code) the following definitions apply

Artificial Waterbody	A constructed waterway, including a constructed channel, dam or lake
Bund	Watertight wall or embankment designed to prevent liquid or solids entering and/or exiting an area
Calving Pad	A separate area for birthing dairy animals that provides a warmer and drier alternative to the paddock. OUTCOME 1

Dairy premises effluent must not leave the farm boundaries or enter surface waters or groundwater, unless treated and discharged in a manner approved by the relevant regulatory authorities.

MINIMUM REQUIREMENTS

- 1.1 Dairy premises effluent must not leave the farm boundaries or enter surface waters or groundwater, unless treated and discharged in a manner approved by the relevant regulatory authorities.
- 1.2 Dairy premises effluent must not enter surface waters, except artificial water bodies wholly contained within the farm boundaries.

OUTCOME 2

There must be an appropriately designed, constructed and operated system for the responsible management of dairy premises effluent.

MINIMUM REQUIREMENTS

- 2.1 Effluent management systems are constructed and managed to relevant regulatory standards, do not pollute or pose environmental harm, and reduce the risk of groundwater contamination and runoff.
- 2.2 An Effluent Management Plan must be developed by trained, independent Livestock Effluent Designer for each dairy premises and submitted to the TDIA for review and approval. The dairy farmer must operate in accordance with a plan approved by the TDIA for those premises.
- 2.3 Effluent Management Plans must reflect the effluent management system in use and must be regularly reviewed by the dairy farmer.
- 2.4 A dairy premises where stock is held for extended periods must have a concrete or other impervious base.
- 2.5 The base of a dairy premises and associated management areas must have bunds around the perimeter or are otherwise designed with appropriate drainage so that all effluent is directed to, and contained within, the effluent management system.
- 2.6 Effluent conveyance methods must not pose a risk to surface water, ground water or soil integrity.
- 2.7 Appropriate contingencies must be in place to contain all effluent within the effluent management system, regardless of adverse weather conditions and/or component failures.

OUTCOME 3

Irrigation or distribution of dairy premises effluent is carried out in an environmentally sound manner.

MINIMUM REQUIREMENTS

- 3.1 The effluent application schedule and rates are appropriate to the farm as assessed in the approved Effluent Management Plan.
- 3.2 Effluent must not be distributed to a sacrificial area, or through an open-ended pipe, unless able to be done in an environmentally sound manner.
- 3.3 Effluent irrigation or distribution systems are constructed and managed to relevant regulatory standards, do not pollute or pose environmental harm, and reduce the risk of groundwater contamination and runoff.

ATTACHMENT 1 – This Attachment does not form part of the code.

MANAGEMENT MECHANISM FOR CODE OF PRACTICE

LEGAL ACTION

This Code of Practice is issued and administered by TDIA under Part 5 of the *Dairy Industry Act 1994*.

Compliance with this Code of Practice is a condition of licence or accreditation for all dairy farmers licensed under the *Dairy Industry Act 1994* or accredited under the *Primary Produce Safety Act 2011* in Tasmania, and licences or accreditations can be suspended or revoked for failure to comply. Compliance will be assessed as part of routine audit inspections, which may be announced or unannounced.

In the event of potential breaches of the Code which may amount to breaches of EMPCA, referral may be made to Municipal Environmental Health Officers (EHO) or the Environment Protection Authority (EPA) who are responsible for administering EMPCA. Various legal options are available under EMPCA, including the issue of an Environment Protection Notice (EPN) on the responsible person concerned whereby:

- The dairy may not be permitted to operate if compliance is not achieved within a specified time frame;
- A charge may be imposed for issue of the notice;
- Ongoing reports of the effluent management system may be required to be prepared by a suitably qualified person. A fee may be charged for each inspection;
- A penalty can be incurred for failure to comply with a requirement of an EPN;
- A person on whom a notice has been served may appeal to the Tasmanian Civil and Administrative Tribunal in relation to the notice.

COMPLAINTS RESOLUTION

Dealing with complaints concerning <u>pollution</u> caused by dairy premises effluent is the role of the local Municipal Council. The EHO/Council Officer on receiving the complaint will decide on the most appropriate course of action to take. Action could involve:

- An inspection to determine the nature of the complaint;
- Contact with the landholder concerned;
- Following inspection, deciding whether the matter needs to be referred to the Environment Protection Authority for assistance or whether legal action is required.
- Contacting TDIA to investigate whether the issue is linked to the effluent management system on farm.

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Animal Welfare (Pigs) Regulations 2025

These regulations -

- (a) prescribe, for the purposes of the Animal Welfare Act 1993 -
 - (i) requirements for ensuring the health and welfare of pigs in certain circumstances; and
 - (ii) matters relating to a Model Code of Practice for the welfare of pigs; and
 - (iii) infringement notice offences and the penalties for those infringement notice offences; and
- (b) are made consequentially on the expiry of the Animal Welfare (Pigs) Regulations (No. 2) 2023.
- (2) Animal Welfare (Transport of Livestock) Regulations 2025

These regulations prescribe, for the purposes of the Animal Welfare Act 1993, transportation requirements for certain species of animal.

(3) Inland Fisheries (Seasons and Waters) Amendment Order 2025

This order amends the Inland Fisheries (Seasons and Waters) Order 1996 to -

- (a) enable acclimatised fish to be taken from Bradys Lake, Lake Binney and Tungatinah Lagoon all year round; and
- (b) remove the restriction on who is permitted to take fish from Plenty River.
