GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Electricity Supply Industry Concession Amendment Order 2025*

This order amends the *Electricity Supply Industry Concession Order 2016* by increasing the daily discounts for the medical cooling or heating concession, the annual electricity concession and the life support concessions.

(2) *Electoral Disclosure and Funding Regulations 2025*

These regulations prescribe, for the purposes of the *Electoral Disclosure and Funding Act 2023* –

- (a) certain records required to be kept, and provided to the Tasmanian Electoral Commission, under that Act; and
- (b) the methods of disclosing certain donations and gifts made under that Act; and
- (c) classes of persons who may be appointed as inspectors under that Act.
