## Personal Information Protection

### **PERSONAL INFORMATION PROTECTION ACT 2004**

#### **EXEMPTION UNDER SECTION 14**

I, Guy Barnett, Attorney-General and Minister for Justice, being and as the Minister responsible for the administration of the *Personal Information Protection Act 2004* ("the Act"), upon being satisfied that the public benefit in doing so outweighs to a substantial degree the public benefit from compliance with section 17 of the Act in respect of Personal Information Protection Principles ("PIPP") 1, 2 and 10, hereby approve an application dated 5 February 2025 made under section 13 of the Act by the Department for Education Children and Young People (DECYP) and the Teachers Registration Board (TRB) for an exemption from compliance with section 17 of the Act, in respect of PIPP 1, 2 and 10 in Schedule 1 to the Act, subject to the following conditions:

1. Any information that, but for this exemption, would be protected by the Act can be collected, used and disclosed between DECYP and the TRB, if the information is, or has the potential to be, relevant to the behaviour and conduct of teachers.
2. If information is disclosed pursuant to a request that is not relevant and is not potentially relevant to the behaviour and conduct of teachers, it will be returned or destroyed as per the election of DECYP or TRB, and in compliance with the *Archives Act 1983*. This does not include information that should be retained so as to preserve the integrity of a record as a whole, or for similar or related purposes.

#### **Details of the Application**

The Department for Education Children and Young People (DECYP) and the Teachers Registration Board (TRB), a body corporate continued under the *Teachers Registration Act 2000*, have applied under section 13 of the *Personal Information Protection Act 2004* ("the Act") for an exemption under section 14 of the Act to allow for the sharing of information relevant to the behaviour and conduct of teachers, in the custody and control of DECYP or the TRB.

The exemption is to ensure that all information relevant to the behaviour and conduct of teachers that is held by DECYP and the TRB can be shared between the two entities. This will assist in improving the safety of children and young people. The exemption is sought in accordance with the interim measure included with Recommendation 6.10 of the Final Report of the Commission of Inquiry into the Tasmanian Government's Responses to Child Sexual Abuse in Institutional Settings.

### **PERSONAL INFORMATION PROTECTION ACT 2004**

#### **EXEMPTION UNDER SECTION 14**

I, Guy Barnett, Attorney-General and Minister for Justice, being and as the Minister responsible for the administration of the *Personal Information Protection Act 2004* ("the Act"), upon being satisfied that the public benefit in doing so outweighs to a substantial degree the public benefit from compliance with the Personal Information Protection Principles, hereby approve an application dated 24 February 2025 made under section 13 of the Act by Homes Tasmania for an exemption from compliance with section 17 of the Act, with respect to the principles in clauses 1 and 10 of Schedule 1 of the Act subject to the conditions specified below and with respect to holding and administering an information technology platform for the provision of housing assistance in Tasmania and which is proposed to centralise information with respect to housing assistance provided in Tasmania by government and non-government housing assistance providers. The new platform will replace an existing centralised database of information with respect to the provision of housing assistance that is held and administered by a third party.

1. With respect to the importation of data from the existing housing assistance information platform into the new platform the exemption is limited to the principles in clauses 1(3)-1(5) and 10(1)(a) of Schedule 1 of the Act and to enable personal information including sensitive information contained in the existing database to be transferred and collected in the new platform for the following purposes:
  - a. To extract de-identified data relating to the provision of housing assistance in Tasmania; and
  - b. To facilitate and inform the provision of housing accommodation services to the individuals to whom the personal information relates.
2. With respect to the future use of the new platform the exemption is limited to the operation of clause 1(4) of Schedule 1 of the Act to enable personal information relating to individuals applying for or provided with housing assistance services to be collected by both Homes Tasmania and non-government housing assistance service providers and entered into the platform held by Homes Tasmania for the same purposes as are identified above in paragraph 1(a) and (b).

## Energy Ombudsman

The following Guidelines were prepared in accordance with the *Energy Ombudsman Act 1998* (the Act), s 39(1), and were published in the *Gazette* on 17 January 2024 in accordance with s 39(4) of the Act.

The Guidelines will govern the preparation of the annual budget in respect of the costs of administering the Act, until they are varied or revoked in accordance with that Act.

### **ENERGY OMBUDSMAN ACT 1998, SECTION 39**

PURSUANT to s 39 of the Act, I revoke all Guidelines previously made under that section, and substitute the following Guidelines.

#### **Guidelines Overview**

These Guidelines have been prepared in accordance with s 39(1) of the Act, and relate to the processes to be followed in preparing a budget in respect of the costs of administering the Act.

The Guidelines are based on the principle expressed in s 39C(1) of the Act, that the costs of administering the budget are to be met by all energy entities in such proportions as are specified in the budget. The expression "energy entity" as defined in the Act, denotes any entity which is:

- (a) an electricity entity within the meaning of the *Electricity Supply Industry Act 1995*; or
- (ab) a retailer within the meaning of the National Retail Law (Tasmania); or
- (ac) an exempt seller within the meaning of the National Energy Retail Law (Tasmania); or
- (ad) a person to whom, or a person who sells electricity to which, s 23 of the *National Energy Retail Law (Tasmania) Act 2012* applies;
- (b) a licensee within the meaning of the *Gas Industry Act 2019*.

The apportionment of the budget is to be based on the payment of membership fees and complaint levies. Each entity is to pay a membership fee in accordance with Section 1 of these Guidelines, if demanded. The entity will also pay a complaint levy if one is payable in accordance with Section 2.

#### **1. The Membership Fee**

Each entity is to pay a membership fee of \$10, if demanded.

#### **2. The Complaint Levy**

The balance of the budget is to be apportioned between energy entities through the imposition of complaint levies.

The Ombudsman will calculate -

- (a) the aggregate number of complaints and enquiries received by the Ombudsman under the Act during the previous calendar year; and
- (b) the percentage of that aggregate number which is attributable to complaints made against, or enquiries made in respect of, each of the energy entities.

Each entity is to pay a levy which represents the percentage of the balance of the budget which is equal to the percentage attributed to that entity in accordance with paragraph (b).

#### **3. Costs to be included in the Budget**

The budget will include the estimated costs of administering the Act in the forthcoming financial year.

If the Ombudsman anticipates that, for good reason, the budget for the current financial year will be exceeded, the amount of the excess may be added to the budget which is in preparation.

If the Ombudsman anticipates spending less than the budget for the current financial year, the anticipated surplus will be credited to the energy entities in proportion to their contributions to that budget. The fact that a surplus is anticipated will also be taken into account in the preparation of the new budget.

## Fee Units

### Fee Units Act 1997

The *Fee Units Act 1997* (the Act) provides for automatic changes in Government fees and charges in accordance with movements in the Hobart Consumer Price Index (CPI). The Act also provides for adjustments to be made on the basis of factors other than movements in the CPI through a fee unit adjustment factor.

In accordance with section 6 of the Act, I give notice that:

- the value of a fee unit for the financial year commencing 1 July 2025 is \$1.91; and
- the adjustment factor used in the calculation of the fee unit is zero.

In determining the adjustment factor for the purpose of section 5(4) of the Act, I have taken into consideration that the overall cost to the Government in providing services for which fees are charged have increased at a rate that is not less than the average movement in the Hobart CPI from 2023 to 2024, being the period relevant to the calculation of a fee unit under the Act.

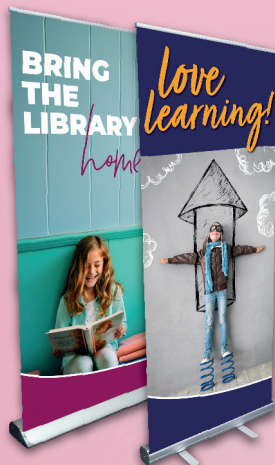
