THREATENED SPECIES PROTECTION ACT 1995**Decision of the Minister for Environment**

I HEREBY GIVE notice in accordance with sections 13(5) and 14(2) of the Act that I propose to make an Order under Section 13(5) to add *Gallinago hardwickii* (Latham's snipe) as vulnerable under Schedule 4 Part 1, add *Ardenna grisea* (sooty shearwater) as vulnerable under Schedule 4 Part 1, omit *Olgania excavata* (cave spider) from rare on Schedule 5 Part 1 and to amend the names for one flora species and four fauna species on the Schedules following taxonomic revision.

Appeals against the proposed order may be made to the Tasmanian Civil and Administrative Tribunal, Resources and Planning Stream, at resourceplanning@tascat.tas.gov.au within 30 days of this notification.

**Preliminary Recommendations of the
Scientific Advisory Committee (Threatened Species)**

IN ACCORDANCE with Sections 15 and 18 of the *Threatened Species Protection Act 1995* (TSP Act) it is hereby advised that the Committee has made the following preliminary recommendations at its meeting on 25 August 2025 to amend the Schedules of the TSP Act. Specifically, the Committee recommends to add *Tringa nebularia* (common greenshank) and *Brachyscome tasmanica* (Tasman daisy) as endangered, to add *Calidris tenuirostris* (great knot) as vulnerable, and to omit *Haloragis heterophylla* (variable raspwort), *Gratiola pubescens* (hairy brooklime), *Parietaria debilis* (shade pellitory), and *Teucrium corymbosum* (forest germander) from rare.

Interested parties are invited to provide any scientific information that relates to these species' conservation assessment to the Scientific Advisory Committee (Threatened Species) by email: threatenedspecies.committees@nre.tas.gov.au within 30 days of the date of this notice.

FISHERIES (SCALEFISH) RULES 2015

NOTICE OF THE DATES OF THE CLOSED SEASON FOR PART OF THE SCALEFISH FISHERY AND NOTICE OF SCALEFISH FISHERY CLOSURE TO SPECIFIC ACTIVITIES

I, Dr David Midson, General Manager (Marine Resources) in the Department of Natural Resources and Environment Tasmania, acting pursuant to a delegation from the Minister administering the *Living Marine Resources Management Act 1995*, hereby determine under rule 11 of the *Fisheries (Scalefish) Rules 2015* (the Rules):

- A. That the dates of the closed season for that part of the Scalefish fishery for garfish (family *Hemiramphidae*) specified in schedule 1 are from:
 - 15 November 2025 to 14 December 2025 inclusive;
 - 15 November 2026 to 14 December 2026 inclusive;
 - 15 November 2027 to 14 December 2027 inclusive; and,
- B. That the dates of the closed season for that part of the Scalefish fishery for garfish (family *Hemiramphidae*) specified in schedule 2 are from:
 - 15 January 2026 to 14 February 2026 inclusive;
 - 15 January 2027 to 14 February 2027 inclusive;
 - 15 January 2028 to 14 February 2028 inclusive; and
- C. That the parts of the Scalefish fishery specified in schedule 1 and schedule 2 are closed to, or in respect of, the activities specified in schedule 3.

SCHEDULE 1

All that part of the Scalefish Fishery in State waters adjacent to the east, west and south coasts of Tasmania south of:

- (a) in the west, an imaginary line starting at Cape Grim and then running due west along the line of latitude at 40°40'S to the limit of State waters; and
- (b) in the east, an imaginary line starting at Cape Naturaliste and then running due east along the line of latitude at 40°50'S to the limit of State waters.

SCHEDULE 2

All that part of the Scalefish Fishery in State waters adjacent to the north coast of Tasmania and in Bass Strait north of:

- (a) in the west, an imaginary line starting at Cape Grim and then running due west along the line of latitude at 40°40'S to the limit of State waters; and
- (b) in the east, an imaginary line starting at Cape Naturaliste and then running due east along the line of latitude at 40°50'S to the limit of State waters.

SCHEDULE 3

The take or possession of all species of garfish (family *Hemiramphidae*).

All coordinates of latitude and longitude specified in this notice are to be determined by reference to the Geocentric Datum of Australia (also known as "the GDA" or "GDA94") as defined in the *Commonwealth Gazette* No. GN 35, 6 September 1995.

Any expression used in this public notice having a particular meaning under the Act or the Rules has the same meaning in this public notice as it has in the Act or the Rules.

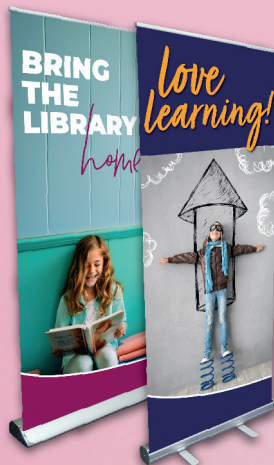
